### **Collaboration Disclaimer**

#### 1. Introduction

- 1.1 This disclaimer shall govern the terms and conditions of Connected Switchgear's offer for collaboration of product idea and or design in order to bring to Commercialisation.

# 2. Intellectual Property

  - by submitting your idea or design to us you express to us that any intellectual property rights created by way of your design prior to its contribution with us rests solely with you, and no third party or entity.
  - b) by your submission you further express that you have not entered into any other binding agreement whatsoever with any other party in respect of your idea and or design submitted to us.
  - c) upon contributing your idea or design to Connected Switchgear you give Connected Switchgear your expressed permission to develop, improve, design, or to use your idea or design in order for Connected Switchgear to bring it to Commercialisation.
  - d) that we, together with our licensors, have vested intellectual property rights in relation to any product developed as a result of your collaboration with us and expressly and exclusively permit us to use your idea or design as a basis for improvement to final design.
  - e) That all the copyright and other intellectual property rights created by way of Connected Switchgears involvement to bring your idea or design to Commercialisation are reserved exclusively by Connected Switchgear.

#### 3. Warranties

- 3.2 Until such times as a binding Heads of Agreement is executed, and in our sole discretion and without notice or explanation we reserve the right to discontinue any collaboration between us; and save to the extent expressly provided otherwise in this disclaimer, you will not be entitled to any compensation or other payment upon the discontinuance or alteration of any collaboration.
- 3.3 To the maximum extent permitted by applicable law and subject to Section 4.1, we exclude all representations and warranties relating to the subject matter of this disclaimer.
- 3.4 Upon submission of your idea and or design, Connected Switchgear will undertake an evaluation in respect of that idea or design with a view to its Commercialisation without making any warranties in terms of the potential value of the Commercialisation of your idea or design.

#### 4. Limitations and exclusions of liability

- 4.1 Nothing in this disclaimer will:
  - (a) limit or exclude any liability for death or personal injury resulting from negligence;
  - (b) limit or exclude any liability for fraud or fraudulent misrepresentation;
